### *Entry Fee*

Your entry fee (\$50/team, \$100 for both boys and girls) should be mailed to Bloomington High School North, Attention Athletics, 3901 North Kinser Pike, Bloomington, IN 47404. Please make checks payable to Bloomington North Athletics. Please mail your check by Monday, August 14<sup>th</sup> or bring them to the race August 19th and give them to Bloomington North's Athletic Director, Andy Hodson.

### *Parking*

There will be a charge to park for the meet. The money collected is part of the agreement with the Sports Center and is used for course upkeep and collected by the Sports Center the day of the meet. Their website says that the fee is \$5 per person.

Heading west on I-70 get off at the State Road 59 exit in Brazil Indiana.  
Turn left proceed, couple hundred yards and turn right onto n Hwy 42  
Continue heading west for approximately 12-15 miles.  
You should see a sign that says LaVern Gibson Championship Cross Country Course.  
Turn right on Tabortown Road then turn left at the entry gate.

### *Awards*

The top ten individuals will receive a medal. Runners 11-20 will receive ribbons. The first place team will receive a team championship trophy and ribbons for their first seven runners.
